## EXAMINATION GRIEVANCE REDRESSAL COMMITTEE

The purpose of the Committee is to redress the grievance of the students related to the examination conducted by the college and the university. The students have to approach the committee to voice their grievances related to the examination. The Students may send the grievance to the Principal over email or put the note in the Complaint/Grievance box kept at the reception / Administrative Office. The committee redresses the grievances by sorting out the problems promptly and judiciously.

**I. OBJECTIVES:** The objective of the Examination Grievance Redressal Committee is to develop a responsive and accountable attitude among all the stakeholders in order to maintain a harmonious educational atmosphere in the institute. This Grievance Committee is constituted to deal with the examination related issues faced by the students in the college and from the university. The objectives of the examination grievance redressal committee are:

1. Encouraging the Students to express their grievances / problems freely and frankly, without any fear of being victimized.
2. To determine in an objective and expert manner whether a student meets the requirements with regard to attendance, assignment, and any such other requirements according to the guidelines by the University for the Respective Course for the eligibility to allow the students to appear into the examination.
3. To safeguard and monitor the quality of internal examinations and to supervise the internal examinations.
4. To establish procedures and instructions within the framework for assessing and determining the results of internal examinations.
5. To grant an exemption/ consideration to students in certain cases from taking examinations

6. To safeguard the quality of the organization and the examination procedures.
7. To take measures against fraud and malpractice during internal and university exams.
8. To respond to any issues that the students may face related to the internal and university examination
9. To help students in overcoming any difficulties that may arise relating to the internal and university exams.
10. Any such other issues that the committee may deem fit for the purpose of internal and external examination or any such issues that are considered proper by the committee.

The Grievances may broadly include the following complaints of the aggrieved students

1. Grievance related to Assessment
2. Grievance related to Victimization
3. Grievance related to Attendance
4. Grievance related to charging of exam fees
5. Grievance regarding to conducting of Examinations
6. Grievance regarding Harassment by colleague students or the teachers etc.

**II. SCOPE:** The committee will deal with Grievances received in writing from the students about any of the following matters:-

1. Academic Matters: Related to Internal and University Examination
2. Other Matters: Related to malpractice, fraud etc during exams or any such other issues related to examination

**III. FUNCTIONS:**

1. The cases will be attended promptly on receipt of written grievances from the students
2. The committee formally will review all cases pertaining to the examination and will act accordingly.
3. The committee will give report to the principal about the cases attended to and the number of pending cases, if any, which require direction and guidance.
4. The committee shall maintain the register and make the entries of each grievance filed and heard and disposed with proper details.

#### IV. COMMITTEE COMPOSITION: The Examination Grievance Redressal

Committee comprises of the following members:

1. THE PRINCIPAL - CHAIRPERSON
2. THREE SENIOR FACULTIES- MEMBERS
3. ONE ADMINISTRATIVE OFFICER/ SUPDT.

#### V. PROCEDURE FOR LODGING THE GRIEVANCE:

1. The students may feel free to put up the grievance in writing/ in the appropriate mode or format and drop it in the complaint/grievance box.
2. The students may feel free to report any difficulties pertaining to the examination through the class teacher, the mentor or through principal or any teaching staff before the committee

#### VI. PROCEDURE OF HEARING THE GRIEVANCE:

1. The Examination Grievance Redressal Committee will act upon those cases which have been forwarded along with the necessary and supportive documents.
2. The Examination Grievance Redressal Committee will assure that the grievance has been properly solved in a stipulated time limit provided by the committee on the case to case basis.
3. The Examination Grievance Redressal Committee shall give appointment to the aggrieved students to hear their examination grievance/s from time to time.
4. The Examination Grievance Redressal Committee shall take necessary steps/actions to address the student's examination grievance/s.
5. The Examination Grievance Redressal Committee shall assure that the grievance has been properly solved in a stipulated time limit.
6. The Examination Grievance Redressal Committee shall issue any directions/guidelines to such persons/staff in order to address the examination related issues of the students at the college level.

#### VII. RESPONSIBILITY FOR REDRESSAL:

1. The final responsibility for Examination grievance Redressal rests with the Principal

3. Every Examination grievance is expected to be resolved within a reasonably period.
4. The Examination Grievance Redressal Committee of the college shall monitor status and progress of grievance Redressal and shall furnish report on grievance Redressal position to the principal from time to time.

**VIII. EXCLUSIONS:** The grievance Redressal cell shall not entertain the following issues:

1. Decisions of the executive council, academic council, board of studies and other administrative or academic committees constituted by the university.
2. Decisions with regard to award of scholarship, fee concessions, medals etc;
3. Decisions made by the university with regard to malpractice, fraud, disciplinary matters and misconduct.
4. Decisions of the university about admissions in any courses offered by the institute.
5. Decisions by competent authority on assessment and examination result.
