REPORT

CLARC of B.M.S. College of Law as a part of CREAT internship had organized a visit to Eureka Analytical Services Pvt Ltd on 16/06/2023. It is a private food laboratory located in Banaswadi, Bangalore. The lab authorities of Eureka Dr. Gowri provided information regarding the testing of packed food products, adulteration of food, the process of licensing and testing of imported food products to students. Various tests are conducted to check the level of contamination in food for which different machines are used such as ICPMS for testing the presence of heavy metals and similarly, ICPOES is a machine used to test the presence of minerals. The laboratory collects food samples from food manufacturers, exporters to test the contents of food. The laboratory also receives food samples from consumers as well if there are any genuine issues regarding packed food the consumers. Dr. Gowri also spoke about the liability of the laboratory for giving any incorrect test report to the food producers and they are required to pay heavy compensation to food producers.

Students had the opportunity to view the working of different machinery and processing of food for its testing. The laboratory consists of 3 floors and on each floor different products such as dairy products, meats, spices, fruits pulps, etc, are tested in specific ways as per the requirements. Hence the lab tour was very informative as it increased students' knowledge about adulteration and the procedures that take place to test and verify the same. The visit to the lab escalated the need for spreading awareness among consumers regarding food safety and the importance of healthy food for survival.

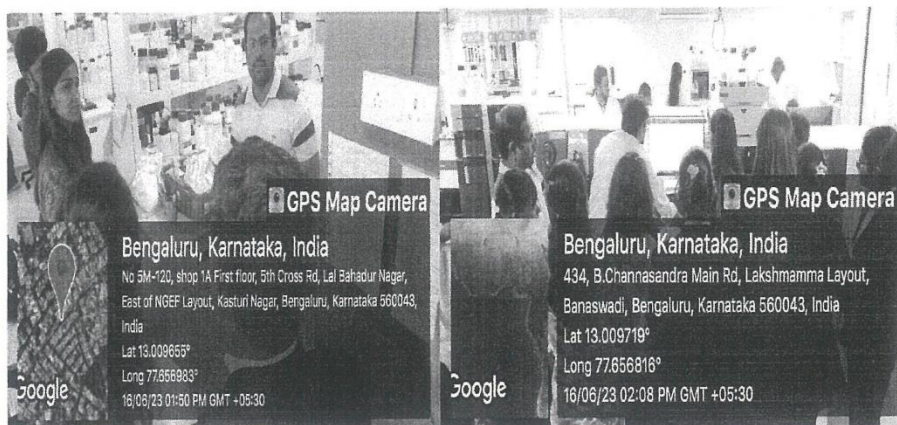
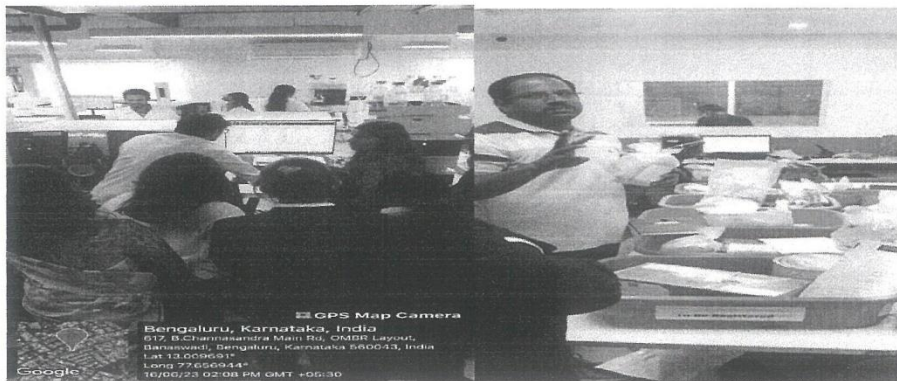

Consumer Law Advocacy and Research Centre (CLARC) in association with CREAT & OUTLAWED organised a workshop on "Filing RTI Application under Right to Information Act, 2005" on 14/11/23 for students. Sri Y.G Muralidharan was invited as a resource person for the workshop.

The purpose of the workshop was to provide hands on experience for students in filing RTI applications. The participants were divided into 6 groups and topics such as BBMP, BESCOM, BMTC, Department of Higher Education, Department of Law and Department of Health were allotted to each group. Sri. YG. Muralidharan briefed participants about significance of RTI act, practical approach to RTI filing, such as one should seek specific information from the government through RTI application, questions cannot be asked, Rule 14 of Karnataka Information Rules under RTI Act, query in the application shall not be more than 150 words, personal information of a person cannot be asked, RTI application shall be filed to Public Information Officer (PIO) of the concerned department. The department shall respond within 30 days. He also explained about procedure of filing of RTI application, appellate authority to file RTI application, if information sought is not as per required, it can be questioned before the Karnataka Information Commission.

The resource person assigned drafting of RTI to all the participants asked them to submit the same before 26/12/23. Subsequently the same can be filed to the concerned department.

The workshop was very interactive and informative. The overall experiences of all the participants were nice. The workshop was concluded with vote of thanks rendered by Dr. Gayathri Bai S Coordinator, CLARC.
